2 - Fahscia Records

The 2012 Fahscia grant of \$1960 was specifically for 3 activities, the purchase of Petrol Vouchers \$ 360 Kitchen Equipment \$250 Television \$ 1350.

The petrol vouchers were purchased in 2012, leaving \$ 1600 for 2013, this money being held by Church Council. Leisure time received the \$250 allocated for kitchen items on April 17 2013. A specific purpose donation towards the television purchase of \$300 was received on February 11 2013. The cost of the television was \$ 1650, Church Council actually paying the account, using the \$1350 received from Fahscia and the Leisure Time payment to Council of the extra \$300 (Cheque 344).

Actual Cost of the Kitchen Items was \$ 276.16, the extra \$ 26.16 is included as an Administration cost.
