# **Church Organ Review**

An Invitation: Members of the congregation are encouraged to come along to an evening in the church on Friday 16 March commencing 8pm to be informed about issues with the existing church organ and to hear a modern electronic organ played by a very accomplished visiting organist. Although you will hear some fine organ music, this will be a "workshop" rather than a concert performance, designed to allow the audience to understand problems associated with our 30 year old organ and to compare its sound with that of a modern electronic organ.

The congregation must soon make an important decision as to refurbishing the current organ or acquiring a new instrument. This evening is designed to inform congregation members so that they are better equipped to participate in a subsequent decision.

Background: Early in 2011 our organists began to notice certain distortions in the sounds of the church organ. As a result, Church Council established a small committee to examine the issues and eventually make recommendations regarding repair or replacement of the organ. Many of the committee are the organists Robert Fleming, Geoff Willis, Elwyn Pedersen and David Williams, plus Ross Lennon and John Snare. Throughout 2011 the committee have made various investigations, consulted potential new organ suppliers, received advice from electronic organs in other church environments.

A major source of music distortion of our organ was found to be due to "blown" loudspeakers in the units mounted in the enclosures on the left hand wall adjacent to the large screen. These loudspeakers have now been temporarily removed, substantially reducing the level of distortion. The organ sound currently emanates virtually solely from the loudspeaker units mounted in the wall above the organ. There remain, however, more subtle levels of distortion within the organ requiring attention, and 30 years of keyboard and pedal board wear requiring repair.

Aside from issues of distortion, it is generally accepted that the pipe organ sound achievable from the 30 year old electronics of our organ, falls well short of the richness of sound produced by a

modern electronic organ. This is accentuated by the fact that our organ does not have a reverberation unit installed.

Potential Actions: One course of action would be to refurbish the present organ, possibly fitting a reverberation unit in the process, to give its music more "life" and to replace its "blown" loudspeakers. The cost of this action is not yet firm but is expected to be in the vicinity of \$4000 to \$6000. Whilst the reliability of our organ has been excellent and its manufacturer, Allen, continues to provide strong product support, this level of expenditure on a 30 year old organ must be considered carefully.

An obvious alternative would be to purchase a new organ whose modern electronics would provide a "brighter" sound with more flexibility of music styles. We could then look forward confidently to another 30 years instrument life with low maintenance. The cost of this alternative, however, would obviously be greater, about \$22,000 to \$28,000 depending on what features were thought desirable.

Another possibility would be to convert our organ to a computer based system, the best known of which is the Hauptwerk system. This system simulates closely the majestic sound of many famous pipe organs such as the Salisbury Cathedral organ. Despite the allure of the amazing sounds which can be produced this way, the committee has rejected this approach, mainly on the grounds that the level of technical support currently available is inadequate to ensure prompt correction of faults which might occur on a new instrument.

The Decision: The Congregation must in due course take a decision on the course to pursue, taking into account the costs involved as well as factors such as the appropriateness of organ music as the basis for worship music in the future, and the likelihood of having organists capable of exploiting the upgraded capabilities of a new organ.

We urge you to come, hear and discuss the arguments for and against the various possibilities, and thus be prepared to contribute to the decision to be made at a subsequent date.
